

The Government of Nepal [GoN] and Bhadrapur Municipality have allocated funds towards the cost of Health Building and intends to apply part of the funds to cover eligible payments under the contract for **Building of Bhadrapur Municipality Ward no 2,4,6 & 7**, Jhapa district, contract identification no. **as per below table**. Bhadrapur Municipality invites sealed bids from national bidders for the **Building**. Hard copy of the bidding documents may be purchased from the office stated below by eligible bidders on the submission of a written application and upon payment of a non refundable fee of NRs. 3000.00 for each Bids **within office time onto 23<sup>th</sup> May 2019 (09<sup>th</sup> Jestha 2076)**.

- (a) Sealed bid must be submitted to the office stated below on or before **12.00 hrs of 24<sup>th</sup> May 2019 (10<sup>th</sup> Jestha 2076)**. Documents received after this deadline shall not be accepted.
- (b) The sealed bids shall be opened in the presence of bidder's representative who chooses to attend at **14:00 hrs of 24<sup>th</sup> May 2019 (10<sup>th</sup> Jestha 2076)**. at Bhadrapur Municipality, Jhapa. Bids must be valid for a period of **90 days** after bid opening and must be accompanied by bid security for each contract ID **as per below table**. The bid security guarantee must conform to the standard format as specified in the bid document.
- (c) All bids shall be accomplished by a valid bid security of an amount not less than the amount as specified below. The bid security guarantee by only the commercial bank approved by Nepal ratriya bank shall be accepted by the employer. If the bidder wishes to submit the security in the form of cash, the bidder shall be deposited cash in deposit account no 2210303003002 of Bhadrapur Municipality office, Bhadrapur, Jhapa in Rastriya Banijya Bank, Bhadrapur, Jhapa and shall submitted bank deposited voucher along with the bid.
- (d) If the last date of purchasing, submission and opening falls on a government holiday, then the next working day shall be considered as the last day.
- (e) Bidders are advised to visit site and assess the actual site conditions before submitting their bid.
- (f) Pre-bid meeting shall be held at the office named below at **14:00 hrs of 14<sup>th</sup> May 2019 (31<sup>th</sup> Baisak 2076)**. The bidder or his/her authorized representative is encouraged to attend the pre-bid meeting. The purpose of the meeting is to clarify any issue regarding the bid documents and opening of bids.
